I certify that I am the parent or legal guardian of the above listed child who will be a participant in the North Georgia Junior/Senior Youth Camp. I have been informed that during camp, my child will participate in recreational activities that could include risk, such as transportation to/from camp, sports and recreational games, tubing, roller skating, as well as other risks that are not foreseeable. I agree that I will discuss with my child the importance of following the guidelines, instructions and recommendations of the Camp staff members and other adults assigned to the event. As a condition of participation in the above activity or event, both parent/guardian and camper agrees to the code of conduct. I am aware that the North GA Christian Education Board is not responsible for any items that are lost, stolen, or broken.

For the sole consideration of the North Georgia Youth Camp's arranging for the camper's participation in the camp event, I hereby release and forever discharge the North Georgia District Christian Education Board, their members individually and their officers, agents and employees from any and all claims, demands, rights and causes of action of whatever kind that I may have, either on my own behalf or in my capacity as legal representative of my child, arising from or in any way connected with my child's participation in the above named event. I understand that the acceptance of this release, Waiver of Liability, and Covenant Not to Sue by the Youth Board shall not constitute a waiver, in whole or part, of sovereign immunity by said Board, its members, officers, agents and employees. I certify that my child is participating in the event with my full knowledge and consent and that he/she has my permission to participate in all activities.

I understand that should a health problem arise, I will be notified, but that if I cannot be reached by telephone, such medical treatment, including surgery, as deemed necessary by competent medical personnel could be rendered; that necessary information may be released for insurance purposes; and that I accept full responsibility for all medical expenses. By signing this form, my child has permission to participate in all activities provided by the North Georgia C.E. Board. I also understand that there will be rules set forth by C.B. Board Leaders that my child is to follow. Failure to obey these rules could result in dismissal from the camp.
